RESOLUTION NO. 71-6

RESOLUTION APPROVING THE ANNEXATION OF TERRITORY TO
SANITARY DISTRICT NO. 6

CENTER ROAD ANNEX 1970-11

WHEREAS, a resolution of application number 1180 has been filed by Sanitary District No. 6 together with evidence of written consent of all property owners within the proposed annexation; and

WHEREAS, the Commission has found the territory to be annexed to be uninhabited; and

WHEREAS, Sanitary District No. 6 has not requested the Commission to hold a noticed public hearing in accordance with Government Code Section 56256.

NOW, THEREFORE, the Local Agency Formation Commission of the County of Marin does hereby resolve, determine and order as follows:

1. The proposed annexation to Sanitary District No. 6 is approved subject to the condition that the same territory is annexed to the City of Novato.

2. The territory proposed for annexation is uninhabited and is designated as Center Road Annex 1970-11.

3. Sanitary District No. 6 shall be the conducting district for further proceedings to annex this territory and the Board of Directors of that district is authorized to conduct the annexation proceedings in compliance with this resolution and the resolution of application. Such proceedings may be without notice, hearing or election.

EXHIBIT "A"

BEGINNING at a point on the existing boundary of Sanitary District No. 6 of Marin County, said point being on the southerly line of Center Road at its intersection with the westerly line of Lot 114 as said Road and Lot are shown upon that certain map entitled "Amended Map No. 1 of Subdivision 'E' of the Novato Ranch, Marin County, California", filed July 6, 1910 in Book 3 of Maps at Page 54, Marin County Records; running thence from said point of beginning along said Sanitary District boundary and along said southerly line of Center Road South 75° 45' East 330 feet to the intersection of said southerly line of Center Road with the easterly line of said Lot 114 (3 O.R. 54); thence leaving said southerly line of Center Road and continuing along said Sanitary District boundary South 14° 15' West 992.49 feet; thence leaving said Sanitary District boundary North 80° 08' West 330.96 feet to said westerly line of Lot 114; thence along said westerly line of Lot 114 North 14° 15' East 719.00 feet to a point on said Sanitary District boundary; thence running along said Sanitary District boundary and continuing along said westerly line of Lot 114 North 14° 15' East 298.90 feet to the point of beginning.
