RESOLUTION NO. 69-6

RESOLUTION APPROVING THE ANNEXATION OF TERRITORY TO
SANITARY DISTRICT NO. 6

CENTER ROAD ANNEXATION 1969-1

WHEREAS, a resolution of application No. 1056 has been filed by Sanitary District No. 6, together with evidence of written consent of all owners of property within the proposed annexation; and

WHEREAS, the Commission has found the territory to be annexed to be uninhabited; and

WHEREAS, the Sanitary District No. 6 has not requested the Commission to hold a noticed public hearing in accordance with Government Code Section 56261.

NOW, THEREFORE, BE IT RESOLVED by the Marin County Local Agency Formation Commission, in accordance with the District Reorganization Act of 1965, that it does hereby approve the annexation of territory known as Center Road Annexation 1969-1 to Sanitary District No. 6 with the following determinations:

1. Sanitary District No. 6 shall be the conducting District for further proceedings to annex this territory and the Board of Directors of that District is directed to initiate annexation proceedings in compliance with this resolution and the resolution of application. Such proceedings may be without notice, without hearing, and without election.


2. The territory proposed for annexation shall be designated as Center Road Annexation 1969-1.

Center Road Annex. 1969-1

"Exhibit A"

Beginning at a point on the existing boundary of District No. 6 of Marin County, said point being on the Southerly line of Center Road distant North 75° 45' West 396.00 feet and South 10° 21' 36" West 15.03 feet from the Northeast corner of Lot 111 as said lot is shown upon that certain map entitled "Amended Map No. 1 of Subdivision 'E' of the Novato Ranch, Marin County, California", filed July 6, 1910 in Book 3 of Maps at Page 54, Marin County Records; thence from said point of beginning, leaving said Southerly line of Center Road and running along said Sanitary District boundary South 10° 21' 36" West 140.32 feet; thence South 75° 45' East 87.44 feet; thence leaving said Sanitary District boundary North 14° 15' East 140.00 feet to a point on said Sanitary District boundary and on said Southerly line of Center Road; thence along said Sanitary District boundary and along said Southerly line of Center Road North 75° 45' West 96.96 feet to the point of beginning.
