RESOLUTION APPROVING THE ANNEXATION OF TERRITORY TO
SANITARY DISTRICT NO. 6

BRET COURT ANNEXATION 1969-7

WHEREAS, Sanitary District No. 6 of Marin County Resolution No. 1075, a resolution of application to annex certain territory, has been filed with the Executive Officer of this Commission; and

WHEREAS, at the time and in the form and manner provided by law, the Executive Officer has given notice of a public hearing by this Commission upon said resolution; and

WHEREAS, the public hearing by this Commission was held upon the date and at the time specified in said notice of public hearing.

NOW, THEREFORE, the Local Agency Formation Commission of the County of Marin does hereby resolve, determine, and order as follows:

1. Sanitary District No. 6 of Marin County Resolution No. 1075 is approved subject to the terms and conditions contained therein.
2. The territory proposed for annexation shall be designated as the Bret Court Annexation 1969-7 and is uninhabited.
3. Sanitary District No. 6 shall be the conducting district for further proceedings to annex this territory and the Board of Directors of that district is directed to initiate proceedings in compliance with this resolution and the resolution of application.
4. The Executive Officer is hereby authorized and directed to mail certified copies of this resolution in the manner and as provided in Section 56272 of the Government Code.

BEGINNING at a point on the existing boundary of Sanitary District No. 6 of Marin County, said point being the most Northerly corner of Lot 10 as shown upon that certain map entitled "Bret Court Subdivision, Novato, California", filed April 16, 1965 in Volume 13 of Maps at Page 12, Marin County Records; running thence from said point of beginning along said Sanitary District boundary and along the Northwesterly line of said Lot 10 South 29° 15' West 73.73 feet; thence leaving said Northwesterly line of Lot 10 and continuing along said Sanitary District boundary South 60° 45' East 330.00 feet; thence North 29° 15' East 50.27 feet; thence leaving said Sanitary District boundary North 53° 33' 51" West 233.97 feet; thence South 10° 48' 55" West 19.96 feet to the Easterly corner of said Lot 10; thence along the Northeasterly line of said Lot 10 North 53° 33' 51" West 105.00 feet to the point of beginning.
