RESOLUTION NO. 75-24

RESOLUTION MAKING DETERMINATIONS AND APPROVING THE TRANSFER
OF TERRITORY DESIGNATED AS THE FREITAS TRANSFER FROM
THE CITY OF SAN RAFAEL TO THE CITY OF SAN ANSELMO

WHEREAS, application to transfer certain territory from the City of San Rafael to the City of San Anselmo has been filed with the Executive Officer of this Commission; and

WHEREAS, at the time and in the form and manner prescribed by law, the Executive Officer has given notice of a public hearing by this Commission on said application; and


WHEREAS, the public hearing by this Commission was held upon the date and at the time and place specified in said notice of public hearing.

NOW, THEREFORE, the Local Agency Formation Commission of the County of Marin DOES HEREBY RESOLVE, DETERMINE AND ORDER as follows:

1. The application proposing the transfer of territory described as the Freitas Transfer from the City of San Rafael to the City of San Anselmo is approved;
2. The boundaries of the territory approved to be transferred are those set forth in Exhibit A attached hereto and incorporated herein; and said territory shall be designated as the "Freitas Transfer", and is found to be uninhabited.
3. The Board of Supervisors of the County of Marin is designated as the conducting body for further proceedings on the Freitas Transfer; and said proceedings shall be taken as prescribed by law and in compliance with this resolution.

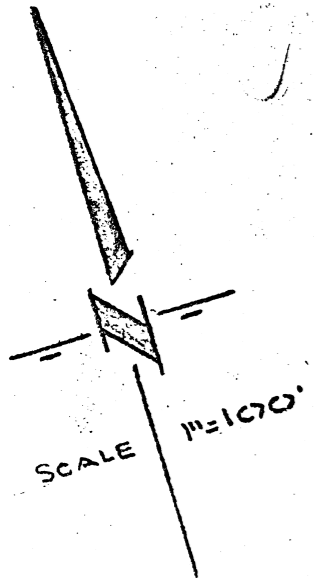

Parcel contains .036 acres ±.

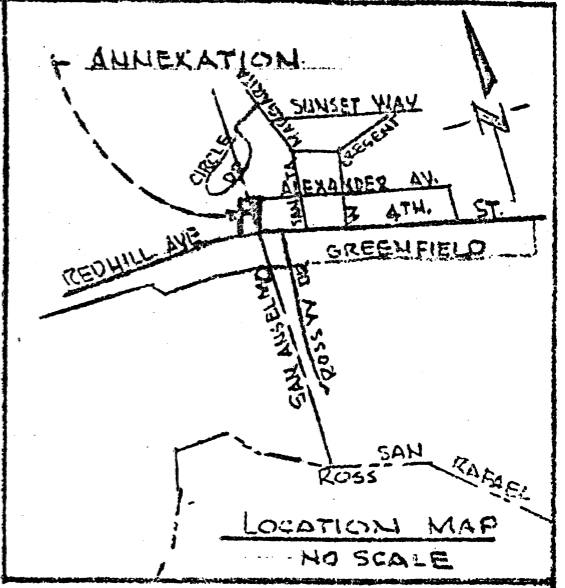
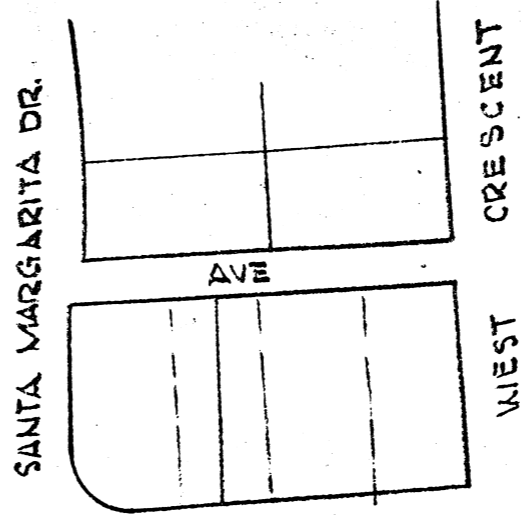
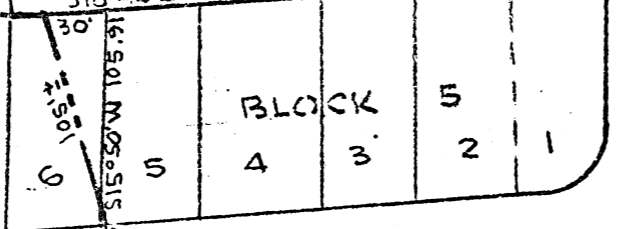
