RESOLUTION NO. 77-5

RESOLUTION MAKING DETERMINATIONS AND APPROVING THE ANNEXATION OF  
TERRITORY DESIGNATED AS "McCLAY ROAD ANNEXATION NO. 7"  
TO THE CITY OF NOVATO

WHEREAS, a proposal for the annexation of territory to the City of Novato has been filed with the Executive Officer of this Commission; and

WHEREAS, said proposal was made in the form of application submitted by the City of Novato in accordance with the provisions of the Knox-Nisbet Act, Chapter 6.6 (commencing with Section 54773) of Division 2, Title 5 of the Government Code; and

WHEREAS, at the time and in the form and manner prescribed by law the Executive Officer has given notice of public hearing by this Commission upon said proposal; and

WHEREAS, the public hearing on said proposal was held by this Commission upon the date and at the time and place specified in said notice of public hearing;

NOW THEREFORE, the Local Agency Formation Commission of the County of Marin DOES HEREBY RESOLVE, DETERMINE AND ORDER as follows:

1. Subject to the terms and conditions hereinafter specified, the proposal made by application submitted by the City of Novato is approved.

2. The boundaries of the territory proposed to be annexed shall be those set forth in Exhibit A attached hereto and incorporated herein; and said territory shall be designated as "McClay Road Annexation No. 7" and is found to be uninhabited.

3. The McClay Road Annexation No. 7 is herein approved subject to the following terms and conditions:

Proceedings for the McClay Road Annexation No. 7 shall not be completed by the Executive Officer of this Commission pursuant to Section 54797.2 of the Government Code without documentation to be furnished by the Novato Sanitary District indicated approval of the McClay Road Annexation (1976-14) by their Board of Directors. Said District shall conduct said proceedings in accordance with applicable provisions of the District Reorganization Act commencing with Section 56000 et seq.

4. The City of Novato shall be the conducting agency for further proceedings to annex this territory; and the City Council of Novato is hereby authorized to take further proceedings upon said annexation in compliance with this resolution, the proposal application, and applicable provisions of State law.

5. The environmental documents relevant to the proposed annexation have been reviewed and considered by the Commission in making its final determination.


6. The Executive Officer is hereby authorized to mail certified copies of this resolution in the manner and as prescribed by law.



EXHIBIT "A"

Beginning at a point on the Novato City limits line which bears North 60° 45' 00" West 15.00 feet and North 29° 15' 00" East 322.00 feet from the most Southerly corner of Lot 178 as shown on that certain map entitled, "Map of Subdivision A and B of the Novato Ranch, Marin County, Cal." filed in Book 3 of Maps, Page 36, Marin County Records; thence leaving said City limit line, North 60° 45' 00" West 112.00 feet; thence North 29° 15' 00" East 338.00 feet; thence North 60° 45' 00" West 3.00 feet to the Novato City limits line; thence along said City limits line, Northerly and Easterly to the Westerly right of way line of McClay Road; thence Southerly along said City limits line and right of way line to the point of beginning.
