RESOLUTION APPROVING THE ANNEXATION OF TERRITORY TO  
SANITARY DISTRICT NO. 2

MARIN COUNTRY DAY SCHOOL ANNEXATION 1969-5

WHEREAS, Sanitary District No. 2 of Marin County Resolution No. 29-69, a resolution of application to annex certain territory, has been filed with the Executive Officer of this Commission, and

WHEREAS, at the time and in the form and manner provided by law, the Executive Officer has given notice of a public hearing by this Commission upon said resolution; and

WHEREAS, the public hearing by this Commission was held upon the date and at the time specified in said notice of public hearing.

NOW, THEREFORE, the Local Agency Formation Commission of the County of Marin does hereby resolve, determine, and order as follows:

1. Sanitary District No. 2 of Marin County Resolution No. 29-69 is approved subject to the terms and conditions contained therein.

2. The territory proposed for annexation shall be designated as the Marin Country Day School Annexation 1969-5 and is uninhabited.

3. Sanitary District No. 2 shall be the conducting district for further proceedings to annex this territory and the Board of Directors of that district is directed to initiate proceedings in compliance with this resolution and the resolution of application.

4. The Executive Officer is hereby authorized and directed to mail certified copies of this resolution in the manner and as provided in Section 56272 of the Government Code.


