RESOLUTION NO. 75-23

RESOLUTION MAKING DETERMINATIONS AND APPROVING THE REORGANIZATION
DESIGNATED AS ROCKRIDGE ROAD REORGANIZATION AND INVOLVING
THE DETACHMENT OF CERTAIN TERRITORY FROM THE CITY OF LARKSPUR
AND ANNEXATION OF SAID TERRITORY TO THE KENTFIELD FIRE PROTECTION DISTRICT

WHEREAS, a proposal for a reorganization involving the detachment of certain territory from the City of Larkspur and annexation of said territory to the Kentfield Fire Protection District has been filed with the Executive Officer of this Commission; and

WHEREAS, said proposal was made in the form of a sufficient petition signed by all owners of the affected territory and filed in accordance with provisions of the District Reorganization Act of 1965, Division 1 (commencing with Section 56000) of Title 6 of the Government Code; and

WHEREAS, pursuant to Government Code Section 56261, when application making a proposal for annexation and/or detachment is signed by owners of all affected property owners, this Commission may make determinations with respect to said proposal without notice and hearing.

NOW, THEREFORE, the Local Agency Formation Commission of the County of Marin DOES HEREBY RESOLVE, DETERMINE AND ORDER as follows:

1. Subject to the terms and conditions hereinafter specified, the reorganization proposal made by sufficient petition is approved.

2. The territory proposed to be reorganized shall be designated as the Rockridge Road Reorganization and consists of the following two changes of organization: Detachment of certain territory from City of Larkspur and annexation of said territory to the Kentfield Fire Protection District, said territory being more specifically described in Exhibits A and B attached hereto and incorporated herein, and is found to be uninhabited.

3. The reorganization shall be subject to the following terms and conditions: Upon the date of completion of the reorganization proceedings herein approved, the territory described in Exhibit A shall be considered, and will be, annexed to the Murray Park Sewer Maintenance District; and shall, upon such date, be subject to, and liable for payment of, any taxes, assessments or other charges levied and collected by said sewer Maintenance District for purposes of carrying out the sewerage functions provided by said District.

4. The Board of Supervisors of the County of Marin is designated as the conducting agency for further proceedings, and is hereby directed to initiate such proceedings in compliance with this resolution and provisions of law; and is authorized pursuant to Government Code Section 56261 to take such proceedings without notice and hearing.


5. The Executive Officer is hereby authorized and directed to mail certified copies of this resolution in the manner prescribed in Section 56272 of the Government Code.

Rockridge Road Annexation to the Kentfield Fire Protection District

Beginning at a point on the northerly line of Lot 13 at the intersection of said line with the Limits Line of the Town of Larkspur, California, said point bearing North $89^{\circ}35'$ East 41.605 feet from the northwest corner of said Lot, as said Lot is shown on the Map of Murray Tract recorded in Book 4 of Maps at Page 73, and running thence along said line North $89^{\circ}35'$ East 26.235 feet, thence leaving said line North $55^{\circ}50'$ East 82.24 feet, thence South $38^{\circ}08'$ East 21.04 feet, to a point on the westerly line of Rockridge Road, thence South $72^{\circ}32'$ East 20.00 feet to the centerline of said Road, thence along said centerline South $17^{\circ}28'$ West 80.209 feet, thence South $1^{\circ}28'$ West 70.053 feet, thence South $67^{\circ}28'$ West 29.108 feet to the Limits Line of the Town of Larkspur, California, thence along said Limits Line North $28^{\circ}48'$ West 152.767 feet to the point of beginning.
