RESOLUTION NO. 74-9

RESOLUTION MAKING DETERMINATIONS AND APPROVING THE ANNEXATION OF  
TERRITORY DESIGNATED AS BEL MARIN KEYS BLVD. ANNEXATION 1974-2  
TO SANITARY DISTRICT NO. 6

WHEREAS, a proposal for the annexation of certain territory to Sanitary District No. 6 in the County of Marin, has been filed with the Executive Officer of this Commission; and

WHEREAS, said proposal was made in the form of Resolution No. 1435, a resolution of application adopted by the Board of Directors of Sanitary District No. 6, and was accompanied by written consent signed by all owners of land within the territory proposed to be annexed; and

WHEREAS, pursuant to Government Code Section 56261, when a resolution of application is accompanied by written consent of all owners of land within the territory proposed to be annexed, this Commission may make determinations with respect to said application without notice and hearing.

NOW, THEREFORE, the Local Agency Formation Commission of the County of Marin, does hereby resolve, determine and order as follows:

1. Subject to the terms and conditions hereinafter specified the proposal made by Resolution No. 1435 adopted by the Board of Directors of Sanitary District No. 6 is approved.

2. The boundaries of the territory proposed to be annexed shall be those set forth in the proposal filed with this Commission; and said territory shall be designated as Bel Marin Keys Blvd. Annexation 1974-~~2~~ and is found to be uninhabited.

3. Any resolution ordering the annexation approved by this resolution shall provide that such annexation is ordered subject to terms and conditions specified in the resolution of application.

4. Sanitary District No. 6 is designated as the conducting district for further proceedings; and the Board of Directors of said district is hereby directed to initiate proceedings in compliance with this resolution, and is authorized to proceed without notice or hearing pursuant to Government Code Section 56261.

5. The Executive Officer is hereby authorized and directed to mail certified copies of this resolution in the manner and as described in Section 56272 of the Government Code.



BEL MARIN KEYS BOULEVARD ANNEXATION 1974-2

EXHIBIT "A"

BEGINNING at a point on the existing boundary of Sanitary District No. 6 of Marin County, said point being on the northerly line of that certain tract of land conveyed to Cortez Development Company by deed recorded July 29, 1968 in Book 2228 of Official Records at Page 375, Marin County Records, at its intersection with said Sanitary District boundary, and lying East 54 feet more or less from the northwesterly corner of said tract and from the easterly line of Bel Marin Keys Boulevard; running thence along said northerly line East 945.30 feet to the northeasterly corner of said tract (2228 O.R. 375); thence leaving said Sanitary District boundary and said northerly line North 9° 31' 45" West 515 feet; thence South 75° 45' 25" West 138.50 feet; thence South 81° 28' 25" West 419.00 feet; thence South 78° 06' 18" West 205.12 feet; to a point on said Sanitary District boundary, said point being distant North 78° 06' 18" East 57 feet, more or less, from said easterly line of Bel Marin Keys Blvd.; thence running along said Sanitary District boundary South 16° 41' West 385.57 feet to the point of beginning.
