

RESOLUTION NO. 73-24

RESOLUTION APPROVING AN EXTENSION OF TIME FOR COMPLETION OF PROCEEDINGS FOR THE BAYSIDE ACRES ANNEXATION TO THE SAN RAFAEL SANITATION DISTRICT

WHEREAS, by Resolution No. 70-46 this Commission approved the Bayside Acres Annexation to the San Rafael Sanitation District as requested by that district; and

WHEREAS, this Commission has twice granted one year time extensions to the District for completion proceedings, the second extension being due to expire on October 12, 1973; and

WHEREAS, by Resolution No. 72-46 adopted on September 6, 1972, this Commission, at the request of the district, excluded eight (8) parcels of land from the territory proposed to be annexed because of non-benefit; and

WHEREAS, on December 11, 1972, the District filed a Certificate of Completion with the Secretary of State, State of California, accompanied by a map and legal description of the territory to be annexed; and

WHEREAS, the map and legal description filed with the Secretary of State have been found to be not in compliance with the determinations of this Commission contained in Resolution 72-46; and

WHEREAS, the San Rafael Sanitation District has requested an additional extension of time in order to correctly complete proceedings in compliance with determinations made by this Commission.

NOW, THEREFORE, the Local Agency Formation Commission of the County of Marin does hereby resolve, determine and order that the San Rafael Sanitation District is authorized an extension of time to complete annexation proceedings for the Bayside Acres Annexation to April 12, 1974, and that all other provisions of the Commission's Resolution Nos. 70-46 and 72-46 remain in full force and effect.

WHEREAS, the map and legal description filed with the Secretary of State have been found to be not in compliance with the definitions of this Commission as stated in Resolution 13-01; and

WHEREAS, the San Rafael Political District has requested an extension of time in order to comply with the provisions in said resolution; and

WHEREAS, the Local Agency Formation Commission of the County of Martin does hereby receive, determine and order that the San Rafael Political District be authorized an extension of time to complete and file proceedings for the

San Rafael Annexation to April 30, 1974, and all other provisions of the Commission's Resolution Nos. 13-01 and 13-02 shall remain in full force and effect
