RESOLUTION NO. 71-26

RESOLUTION APPROVING THE ANNEXATION OF TERRITORY TO
SANITARY DISTRICT NO. 6

MENDOCINO LANE ANNEXATION 1971-2

WHEREAS, a resolution of application No. 1237 has been filed by Sanitary District No. 6, together with evidence of written consent of all owners of property within the proposed annexation; and

WHEREAS, the Commission has found the territory to be annexed to be uninhabited; and

WHEREAS, the Sanitary District No. 6 has not requested the Commission to hold a noticed public hearing in accordance with Government Code Section 56261.

NOW, THEREFORE, BE IT RESOLVED by the Marin County Local Agency Formation Commission, in accordance with the District Reorganization Act of 1965, that it does hereby approve the annexation of territory known as Mendocino Lane Annexation 1971-2 to Sanitary District No. 6

with the following determinations:

1. Sanitary District No. 6 shall be the conducting District for further proceedings to annex this territory and the Board of Directors of that District is directed to initiate annexation proceedings in compliance with this resolution and the resolution of application. Such proceedings may be without notice, without hearing, and without election.


2. The territory proposed for annexation shall be designated as Mendocino Lane Annexation 1971-2.

MENDOCINO LANE ANNEX 1971-2

EXHBITI "A"

BEGINNING at a point on the existing boundary of Sanitary District No. 6 of Marin County, said point being distant North 75° 45' 00" West 35.38 feet and North 14° 15' East 173.834 feet from the northeasterly corner of Lot 43 as said Lot is shown upon that certain map entitled "Castlewood Unit 3, County of Marin, California", filed September 7, 1965 in Volume 13 of Maps at Page 38, Marin County Records, running thence from said point of beginning and along said Sanitary District boundary North 75° 45' West 75.0 feet; thence leaving said Sanitary District boundary North 75° 45' West 150 feet; thence North 14° 15' East 160.786 feet to a point on the northeasterly line of Lot 104, as said Lot is shown upon that certain map entitled "Amended Map No. 1 of Subdivision 'E' of the Novato Ranch, Marin County, California", filed July 6, 1910 in Book 3 of Maps at Page 54, Marin County Records; thence along said northeasterly line South 75° 45' East 309.205 feet; thence leaving said northeasterly line South 14° 15' West 160.786 feet; thence North 75° 45' West 79 feet to the point of beginning.
