RESOLUTION NO. 77-8

RESOLUTION MAKING DETERMINATIONS AND APPROVING THE ANNEXATION OF
TERRITORY DESIGNATED AS THE GREAVES ANNEXATION
TO SANITARY DISTRICT NO. 1

WHEREAS, a proposal for the annexation of certain territory to Sanitary District No. 1 in the County of Marin, has been filed with the Executive Officer of this Commission; and

WHEREAS, said proposal was made in the form of a petition submitted by the affected landowner and requesting the initiation of annexation proceedings pursuant to the District Reorganization Act of 1965, Division 1 (commencing with Section 56000) of Title 6 of the Government Code; and

WHEREAS, said petition was signed by all owners of land within the territory proposed to be annexed; and

WHEREAS, pursuant to Government Code Section 56261, when a resolution of application is accompanied by written consent of all owners of land within the territory proposed to be annexed, this Commission may make determinations with respect to said application without notice and hearing,

NOW, THEREFORE, the Local Agency Formation Commission of the County of Marin DOES HEREBY RESOLVE, DETERMINE AND ORDER as follows:

1. Subject to the terms and conditions hereinafter specified, the proposal made by petition submitted by the affected landowner is approved.
2. The boundaries of the territory proposed to be annexed shall be those set forth in Exhibit A attached hereto and incorporated herein; and said territory shall be designated as the "Greaves Annexation"; and is found to be uninhabited.
3. Sanitary District No. 1 is designated as the conducting district for further proceedings; and the Board of Directors of said district is hereby directed to initiate proceedings in compliance with this resolution, and is authorized to proceed without notice or hearing pursuant to Government Code Section 56261.

4. The Greaves Annexation is not and shall not be subject to any terms and conditions.


5. The environmental documents relevant to the proposed annexation have been reviewed and considered by the Commission in making its final determination; a negative declaration has been issued.

6. The Executive Officer is hereby authorized to mail certified copies of this resolution in the manner and as prescribed by law.



PROPOSED ANNEXATION OF
GREAVES ANNEXATION
ROSS VALLEY SANITARY DISTRICT #1

LEGAL DESCRIPTION

Beginning at a point on the existing boundary of Sanitary District #1 of Marin County, said point being the Southeasterly corner of Lot 478 as shown on that certain map entitled 'Map of Kent Woodlands Subd. No. Fourteen', in the County of Marin, California, filed September 27, 1960 in Book 10 of maps at page nine, Marin County Records; running thence S 79° 04' 11" E, 364.71 feet; thence N 13° 15' E, 260 feet to a point on the existing Sanitary District #1 boundary; thence along said boundary Northwesterly and Southwesterly to the point of beginning.
