RESOLUTION APPROVING THE ANNEXATION OF TERRITORY TO  
THE SAN RAFAEL SANITATION DISTRICT

WORLEY ANNEXATION

WHEREAS, the San Rafael Sanitation District has applied for annexation of certain territory to its district; and

WHEREAS, the property owners concerned have submitted written consent to the proposed annexation; and

WHEREAS, the Commission has found the territory proposed for annexation to be uninhabited;

NOW, THEREFORE, it is resolved by the Marin County Local Agency Formation Commission, in accordance with the District Reorganization Act of 1965, that it does hereby approve the annexation of territory known as Worley Annexation to the San Rafael Sanitation District with the following determinations:

1. San Rafael Sanitation District shall be the conducting district for further proceedings to annex this territory and the Board of Directors of that district is directed to conduct proceedings in compliance with this resolution and the application for annexation. Such proceedings may be without notice, without hearing and without election.

2. The territory proposed for annexation shall be designated as Worley Annexation.

## DESCRIPTION WORLEY ANNEXATION TO SAN RAFAEL SANITATION DISTRICT

All that certain real property situate in the County of Marin,  
State of California, and more particularly described as follows:

BEGINNING at the southeast corner of that certain parcel of land described in Deed to Worley recorded in Book 2505 at Page 663, Official Records, County of Marin, said corner being on the boundary of San Rafael Sanitation District, running thence along the southerly line of said Lands of Worley and said District boundary the following courses and distances; South  $83^{\circ}15'$  West 92.35 feet, North  $23^{\circ}58'$  West 80.87 feet and North  $46^{\circ}12'$  West 117.92 feet to the southwest corner of said Lands of Worley; thence leaving the boundary of the San Rafael Sanitation District and continuing along said Lands of Worley North  $58^{\circ}34'$  East 45.00 feet, North  $23^{\circ}58'$  West 98.00 feet, North  $32^{\circ}00'$  West 125.00 feet and North  $50^{\circ}30'$  West 44.19 feet to the southwesterly line of Glenside Way, as said southwesterly line is shown upon that certain map entitled "Amended Record of Survey of Los Ranchitos", filed September 26, 1947 in

Book 2 of Official Surveys at Page 16, Marin County Records;  
running thence southeasterly along said southwesterly line  
35 feet, more or less, to the northwesterly corner of said Lands  
of Worley; thence along the northerly line of said Lands of Worley  
South  $32^{\circ}00'$  East 220 feet more or less, and North  $58^{\circ}56'$  East  
268.42 feet to the northeast corner of said Lands of Worley;  
thence along the easterly boundary of said Lands of Worley South  
 $11^{\circ}27'$  West 341.77 feet to the POINT OF BEGINNING.
