RESOLUTION NO. 70-51

RESOLUTION APPROVING THE REORGANIZATION INVOLVING THE DISSOLUTION OF
SLEEPY HOLLOW FIRE PROTECTION DISTRICT AND THE FORMATION OF THE
SLEEPY HOLLOW COMMUNITY SERVICES DISTRICT

WHEREAS, a petition signed by registered voters applying for a reorganization involving the dissolution of the Sleepy Hollow Fire Protection District and the formation of the Sleepy Hollow Community Services District was filed with the Executive Officer of this Commission; and

WHEREAS, the Executive Officer has determined that this petition is a legally sufficient petition; and

WHEREAS, at the time and in the form and manner provided by law, the Executive Officer has given notice of a public hearing by this Commission upon said petition for reorganization.

NOW, THEREFORE, the Local Agency Formation Commission of the County of Marin does hereby resolve, determine and order as follows:

1. Subject to the terms and conditions hereinafter specified, the petition for reorganization involving the dissolution of the Sleepy Hollow Fire Protection District and the formation of the Sleepy Hollow Community Services District is approved.

2. The boundaries proposed for the Sleepy Hollow Community Services District as set forth in the petition for reorganization are approved.

3. The territory proposed for reorganization is found to be uninhabited.

4. The effective date of the proposed reorganization shall be August 31, 1971.

5. This reorganization shall be subject to the following conditions:

a. The Board of Directors of the proposed district shall be five in number and they shall be elected concurrently with the election on the reorganization itself.

b. The Sleepy Hollow Community Services District shall have the following powers:

- i. Collection of garbage and refuse
- ii. Fire protection
- iii. Public recreation including parks
- iv. Police protection
- v. Conversion of utilities to underground locations

c. An election for a tax override of 15¢ for the Sleepy Hollow Community Services District shall be held concurrently with the election on the reorganization itself.

d. The Sleepy Hollow Community Services District shall be the successor to the Sleepy Hollow Fire Protection District.

e. All property and assets of the Sleepy Hollow Fire Protection District shall be transferred to the Sleepy Hollow Community Services District upon the effective date of the reorganization.

f. The Sleepy Hollow Community Services District shall replace the Sleepy Hollow Fire Protection District as a party to the contract with the City of San Anselmo for fire protection services on the effective date of the reorganization.

6. The Marin County Board of Supervisors is hereby directed to initiate proceedings in compliance with the petition applying for the reorganization and this resolution.
