RESOLUTION NO. 68-16

RESOLUTION EXTENDING THE TIME TO INITIATE PROCEEDINGS FOR ANNEXATION OF TERRITORY TO SANITARY DISTRICT NO. 6: TRUMBULL AVENUE ANNEXATION (1967-9)

WHEREAS, Sanitary District No. 6 of Marin County Resolution No. 976, a resolution determining desirability of amendment or revision of Local Agency Formation Commission Resolution Approving Annexation of Territory and making determinations and requesting the Local Agency Formation Commission of Marin to amend or revise its resolution making determinations, has been filed with the Executive Officer; and

WHEREAS, the Executive Officer has been provided with the written consent of the sole owner of the property involved in the proposed annexation; and

WHEREAS, additional time is needed by Sanitary District No. 6 in order to fulfill the terms and conditions outlined in the Local Agency Formation Commission Resolution No. 68-10.

NOW, THEREFORE, the Local Agency Formation Commission of the County of Marin does hereby resolve, determine, and order as follows:

1. Resolution No. 976 of Sanitary District No. 6 is approved subject to the terms and conditions therein.
2. That Sanitary District No. 6 be allowed until October 8, 1968 to initiate proceedings.
3. That Sanitary District No. 6 be allowed to initiate proceedings without notice or public hearing.



EXHIBIT "A"

BEGINNING at a point on the existing boundary of Sanitary District No. 6 of Marin County, California, said point being on the Southeasterly line of Trumbull Avenue, distant thereon South 29° 15' West 1,490.0 feet from its intersection with the Southerly line of Mill Road as shown upon that certain map entitled, "Amended Map No. 1 of Subdivision 'C' of the Novato Ranch, Marin County, Calif.", filed July 6, 1910 in Book 3 of Maps at Page 53, Marin County Records; thence leaving said Sanitary District boundary and running along said Southeasterly line of Trumbull Avenue South 29° 15' 00" West 465.00 feet; thence leaving said Southeasterly line of Trumbull Avenue North 60° 45' 00" West 175.00 feet; thence North 15° 40' 00" East 428.00 feet; thence North 55° 00' 00" West 218.00 feet; thence South 40° 39' 00" West 392.00 feet; thence South 76° 00' 00" West 698.00 feet; thence South 54° 18' 00" West 385.00 feet; thence North 35° 25' 00" West 645 feet, more or less, to a point on the Westerly boundary of Lot 269 as shown upon that certain map entitled, "Map of Subdivision 'F' of the Novato Ranch, Marin County, Calif.", filed July 6, 1910 in Book 3 of Maps at Page 55, Marin County Records; thence along said Westerly line of Lot 269 North 8° 44' 24" East 580 feet, more or less to a point on said Sanitary District boundary; thence leaving said Westerly line of Lot 269 and running along said Sanitary District boundary South 81° 15' 36" East 904.35 feet; thence North 18° 15' East 132.0 feet; thence South 71° 45' East 930.0 feet; thence South 29° 15' West 225.0 feet; thence South 60° 45' East 245.0 feet to the point of beginning.
