RESOLUTION APPROVING THE ANNEXATION OF TERRITORY TO THE

TERRA LINDA COMMUNITY SERVICES DISTRICT:

TERRA LINDA TERRACE ANNEXATION

WHEREAS a mandatory resolution for the proposed annexation of certain territory to the Terra Linda Community Services District in the County of Marin was heretofore filed with the Executive Officer of this Local Agency Formation Commission, and said Executive Officer has examined said resolution and found it to be mandatory; and

WHEREAS at times and in the form and manner provided by law, said Executive Officer has given notice of a public hearing by this Commission upon said resolution; and

WHEREAS the public hearing by this Commission was held upon the date and at the time and place specified in said notice of public hearing; and

WHEREAS at such hearing this Commission heard and received evidence which was presented and all persons present were given an opportunity to hear and be heard in respect to any matters relating to said resolution.

NOW, THEREFORE, THE LOCAL AGENCY FORMATION COMMISSION OF THE COUNTY OF MARIN DOES HEREBY RESOLVE, DETERMINE AND ORDER as follows:


1. The resolution of the Terra Linda Community Services District proposing annexation of certain territory in Marin County is approved.
2. The territory proposed for annexation is found to be uninhabited.
3. The territory proposed for annexation shall be designated as Terra Linda Terrace Annexation.
4. The Executive Officer is hereby authorized and directed to mail certified copies of this resolution in the manner as provided in Section 56272 of the Government Code.

DESCRIPTION

Terra Linda Terrace Annexation to Terra Linda Community Service District of Marin County

All that certain real property situate in the County of Marin, State of California, described as follows:

BEGINNING at a point on the Southwesterly boundary line of the existing Terra Linda Community Service District; said point being distant South $29^{\circ} 20'$ West 40.36 feet from the west westerly corner of Lot 847, as said lot is shown on that certain map entitled, "Map of Terra Linda No. 12, in the County of Marin, California, being a Resubdivision of a portion of Terra Linda No. 8," recorded September 7, 1956 in Book 9 of Maps, at page 56, Marin County Records; thence leaving said Southwesterly boundary line and running South $29^{\circ} 20'$ West 219.14 feet South $51^{\circ} 20'$ West 289.22 feet, North $41^{\circ} 25' 08''$ West 169.35 feet, North $3^{\circ} 34'$ East 260.00 feet, North $46^{\circ} 14'$ West 167.97 feet, South $61^{\circ} 38'$ West 166.97 feet, North $41^{\circ} 25' 03''$ West 83.5 feet, and North $39^{\circ} 44' 44''$ East 341 feet, more or less, to the Southwesterly boundary line of the existing Community Service District, above referred to, thence along said Southwesterly boundary line South $56^{\circ} 33' 26''$ East 663 feet, more or less, to the point of beginning.
