RESOLUTION APPROVING THE ANNEXATION OF TERRITORY TO
SANITARY DISTRICT NO. 6

CENTER ROAD ANNEX 1968-10

WHEREAS, a resolution of application No. 1043 has been filed by
Sanitary District No. 6, together with evidence of written
consent of all owners of property within the proposed annexation; and

WHEREAS, the Commission has found the territory to be annexed to be
uninhabited; and

WHEREAS, the Sanitary District No. 6
has not requested the Commission to hold a noticed public hearing in accordance
with Government Code Section 56261.

NOW, THEREFORE, BE IT RESOLVED by the Marin County Local Agency Forma-
tion Commission, in accordance with the District Reorganization Act of 1965, that
it does hereby approve the annexation of territory known as _____
Center Road Annex 1968-10 to Sanitary District No. 6
_____ with the following determinations:

1. Sanitary District No. 6 shall
be the conducting District for further proceedings to annex this territory and
the Board of Directors of that District is directed to initiate annexation pro-
ceedings in compliance with this resolution and the resolution of application.
Such proceedings may be without notice, without hearing, and without election.


2. The territory proposed for annexation shall be designated as
Center Road Annex 1968-10.

EXHIBIT "A"

BEGINNING at a point on the existing boundary of Sanitary District No. 6 of Marin County, said point being at the intersection of the Easterly line of Eucalyptus Avenue and the Southerly line of Center Road as said Avenue and Road as shown upon that certain Map entitled "Amended Map No. 1 of Subdivision 'E' of the Novato Ranch, Marin County, California", filed July 6, 1910 in Book 3 of Maps at Page 54, Marin County Records; thence from said point of beginning along said Sanitary District boundary and along said Southerly line of Center Road South $75^{\circ} 45'$ East 353.55 feet to the intersection of the Easterly line of Lot 113 as shown upon that certain Map hereinabove referred to; thence leaving said Sanitary District boundary and said Southerly line of Center Road and running along said Easterly line of Lot 113 South $14^{\circ} 15'$ West 298.90 feet; thence leaving said Easterly line of Lot 113 North $81^{\circ} 25' 30''$ West 332.65 feet, to a point on said Easterly line of Eucalyptus Avenue said point being distant South $10^{\circ} 22'$ West 348.61 feet and South $79^{\circ} 38'$ East 15 feet from the Northwest corner of said Lot 113; thence running across said Eucalyptus Avenue North $79^{\circ} 38'$ West 30 feet to the Westerly line of said Eucalyptus Avenue; thence running along said Westerly line of Eucalyptus Avenue North $10^{\circ} 22'$ East 114.63 feet to a point on said Sanitary District boundary; thence along said Sanitary District boundary and said Westerly line of Eucalyptus Avenue North $22^{\circ} 10'$ East 79.65 feet; thence leaving said Sanitary District boundary and continuing along said Westerly line of Eucalyptus Avenue 140.32 feet to a point on said Sanitary District boundary, said point also being at the intersection of said Westerly line of Eucalyptus Avenue and the Southerly line of Center Road; thence running along said Sanitary District boundary and across said Eucalyptus Avenue South $75^{\circ} 45'$ East 30.06 feet to the point of beginning.
