RESOLUTION NO. 76-3

RESOLUTION MAKING DETERMINATIONS AND APPROVING THE ANNEXATION OF
TERRITORY DESIGNATED AS THE MC CLAY ROAD ANNEXATION 1975-9
TO THE NOVATO SANITARY DISTRICT NO. 6

WHEREAS, a proposal for the annexation of territory to the Novato Sanitary District No. 6 has been filed with the Executive Officer of this Commission; and

WHEREAS, said proposal was made in the form of Resolution No. 1540, a resolution of application adopted by the Board of Directors of Sanitary District No. 6, and requesting the initiation of annexation proceedings pursuant to the District Reorganization Act of 1965, Division 1 (commencing with Section 56000) of Title 6 of the Government Code; and

WHEREAS, said resolution of application was accompanied by written consent signed by all owners of land within the territory proposed to be annexed; and

WHEREAS, pursuant to Government Code Section 56261, when a resolution of application is accompanied by written consent of all owners of land within the territory proposed to be annexed, this Commission may make determinations with respect to said application without notice or hearing.

NOW, THEREFORE, the Local Agency Formation Commission of the County of Marin, DOES HEREBY RESOLVE, DETERMINE AND ORDER as follows:

1. Subject to the terms and conditions hereinafter specified, the proposal made by Resolution No. 1540, adopted by the Board of Directors of Sanitary District No. 6 is approved.
2. The boundaries of the territory proposed to be annexed shall be those set forth in Exhibit A attached hereto and incorporated herein; and said territory shall be designated as the "McClay Road Annexation 1975-9", and is found to be uninhabited.
3. Any resolution ordering the annexation approved by this resolution shall provide that such annexation is ordered subject to the terms and conditions specified in the resolution of application.

4. Sanitary District No. 6 is designated as the conducting district for further proceedings; and the Board of Directors of said District is hereby directed to initiate proceedings in compliance with this resolution, and is authorized to proceed without notice or hearing pursuant to Government Code Section 56261.

5. The environmental documents relevant to the proposed annexation have been reviewed and considered by the Commission in making its final determination.


6. The Executive Officer is hereby authorized to mail certified copies of this resolution in the manner and as described in Section 56272 of the Government Code.

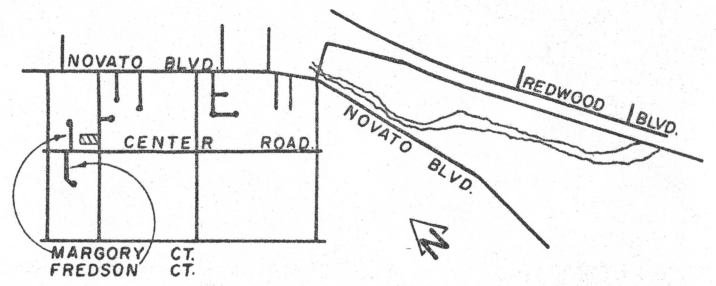
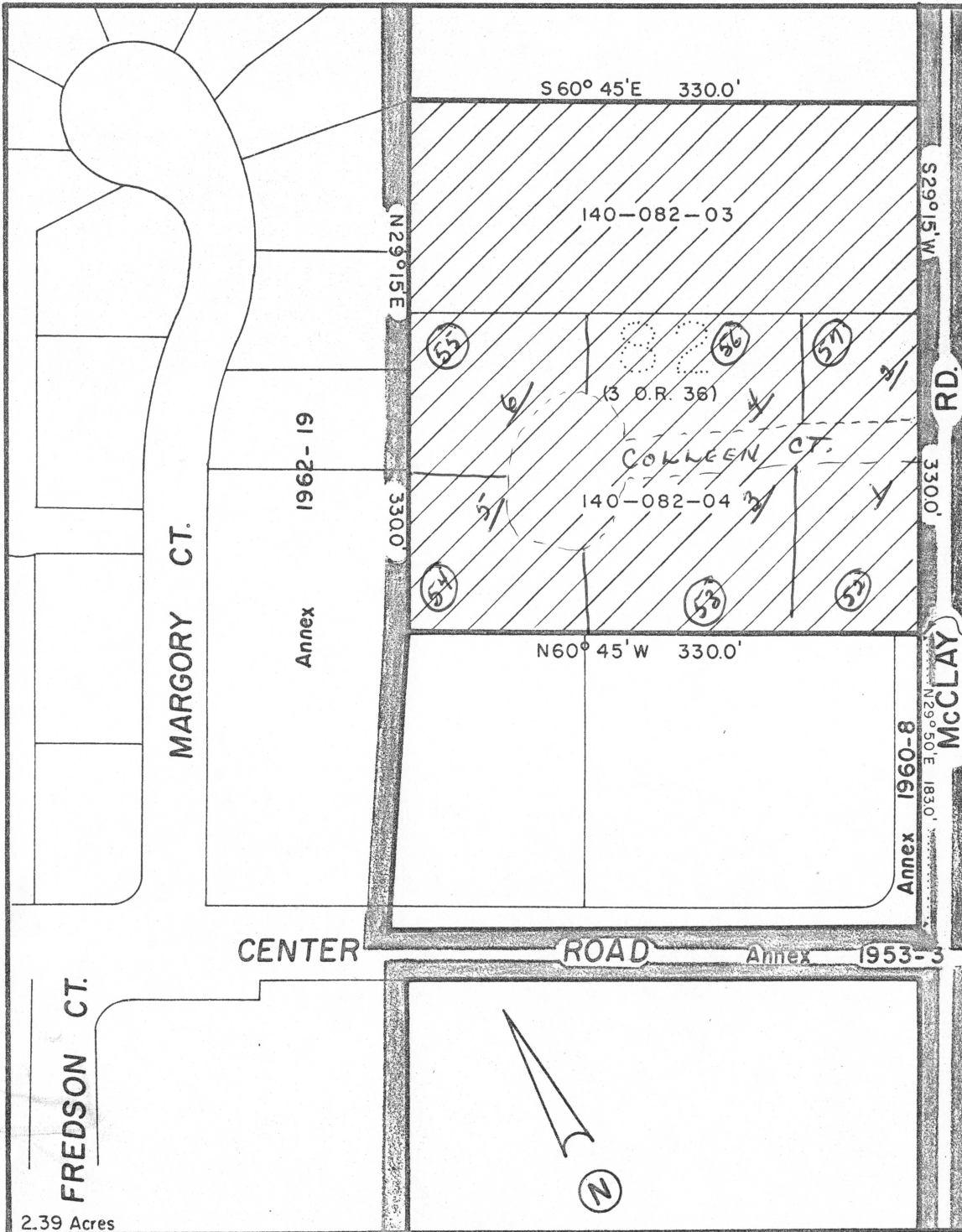

McCLAY ROAD ANNEXATION 1975-9


EXHIBIT "A"

Beginning at a point on the existing boundary of Sanitary District No. 6 of Marin County, said point being on the northwesterly line of McClay Road, (30 feet wide) distant thereon North 29° 50' East 183.0 feet from its intersection with the northeasterly line of Center Road, as said roads are shown upon that certain map entitled "Map of Subdivisions A and B of the Novato Ranch, Marin County, California", filed November 19, 1909 in Book 3 of Maps at Page 36, Marin County Records; thence leaving said Sanitary District boundary and said northwesterly line of McClay Road North 60° 45' West 330.0 feet to a point on said Sanitary District boundary, thence running along said Sanitary District boundary North 29° 15' East 330.0 feet; thence leaving said Sanitary District boundary South 60° 45' East 330.0 feet to a point on said Sanitary District boundary and said northwesterly line of McClay Road; thence running along said Sanitary District boundary and said northwesterly line of McClay Road South 29° 15' West 330.0 feet to the point of beginning.
