RESOLUTION APPROVING THE ANNEXATION OF TERRITORY TO  
SANITARY DISTRICT NO. 6  
NOVATO BLVD. ANNEXATION 1973-7

WHEREAS, a resolution of application No. 1400 has been filed by \_\_\_\_\_

WHEREAS, the Commission has found the territory to be annexed to be uninhabited;

Commission to hold a noticed public hearing in accordance with Government Code Section  
56261.

NOW, THEREFORE, BE IT RESOLVED by the Marin County Local Agency Formation  
Commission, in accordance with the District Reorganization Act of 1965, that it does  
hereby approve the annexation of territory known as Novato Blvd. Annexation 1973-7  
to \_\_\_\_\_ Sanitary District No. 6 \_\_\_\_\_ with the following determinations:

1. \_\_\_\_\_ Sanitary District No. 6 \_\_\_\_\_ shall be the conducting  
District for further proceedings to annex this territory and the Board of Directors  
of that District is directed to initiate annexation proceedings in compliance with this  
resolution and the resolution of application. Such proceedings may be without notice,  
without hearing, without election, and if an election is held, it shall be only in the  
territory to be annexed.


2. The territory proposed for annexation shall be designated as Novato

NOVATO BOULEVARD ANNEXATION 1973-7

EXHIBIT "A"

BEGINNING at a point on the existing boundary of Sanitary District No. 6 of Marin County, said point being on the southwesterly line of Novato Boulevard (County Road) at its intersection with the southeasterly line of Wilson Avenue, as said Boulevard and Road are shown upon that certain map entitled "Map of Subdivisions 'A' and 'B' of the Novato Ranch, Marin County, California", filed November 18, 1909 in Book 3 of Maps at Page 36, Marin County Records, running thence along said Sanitary District boundary and along said southwesterly line of Novato Boulevard South  $60^{\circ} 45'$  East 173 feet; thence leaving said Sanitary District boundary and said southwesterly line of Novato Boulevard South  $29^{\circ} 15'$  West 170 feet to a point on said Sanitary District boundary, said point being on the northeasterly line of Lot 2 as said Lot is shown upon that certain map entitled "Map of Rancho Marin, Novato, Marin County", filed July 22, 1963 in Volume 12 of Maps at Page 7, Marin County Records; thence running along said Sanitary District boundary and along the northeasterly boundary of said Rancho Marin, North  $60^{\circ} 45'$  West 173 feet to a point on said southeasterly line of Wilson Avenue; thence continuing along said Sanitary District boundary and along said southeasterly line of Wilson Avenue North  $29^{\circ} 15'$  East 170 feet to the point of beginning.
