RESOLUTION NO. 69-13

RESOLUTION AMENDING PRIOR RESOLUTION, O'FLAHERTY
ANNEXATION 1968-3 TO SANITARY DISTRICT NO. 2

WHEREAS, the Marin County Local Agency Formation Commission conducted a hearing on January 16, 1969 on the proposed O'Flaherty Annexation 1968-3 to Sanitary District No. 2 and at said hearing evidence was presented showing that one of the two property owners within the proposed annexation had consented to the annexation; and

WHEREAS, Marin County Local Agency Formation Commission Resolution No. 69-5 approved the O'Flaherty Annexation 1968-3 to Sanitary District No. 2 and authorized further proceedings to be conducted by Sanitary District No. 2; and

WHEREAS, Sanitary District No. 2, by letter of March 14, 1969, submitted evidence of consent to the O'Flaherty Annexation 1968-3 to Sanitary District No. 2 by the remaining property owner and further the Sanitary District requested an amendment to the Commission's Resolution No. 69-5 to allow the Sanitary District to complete the annexation without notice, hearing, or election; and

WHEREAS, the Marin County Local Agency Formation Commission considered this request for an amendment at its regular meeting on April 10, 1969.

NOW, THEREFORE, the Local Agency Formation Commission of the County of Marin does hereby resolve, determine, and order as follows:

1. Local Agency Formation Commission Resolution No. 69-5 is amended to authorize Sanitary District No. 2 to complete the O'Flaherty Annexation 1968-3 without notice, hearing, or election.

2. The Executive Officer is hereby authorized and directed to mail certified copies of this resolution in the manner and as provided in Section 56272 of the Government Code.

O'FLAHERTY ANNEXATION
TO
SANITARY DISTRICT NO. 2
1969-1

DESCRIPTION

Beginning at a point in the Northeasterly line of Paradise Drive, distant along said line $N40^{\circ}39'00''W$ 89.07 feet from the intersection of the Northeasterly line of Paradise Drive and the Northwesterly line of Lot 11 as shown upon that certain map entitled "Map of Paradise Cove," filed for record January 10, 1939 in Volume 5 of Maps at page 77, Marin County Records; thence $N34^{\circ}31'00''E$ 472.26 feet to the North line of Lot 20 Section 24 T. 1N., R.6W. M.D.B.& M.; thence along said line West 369.63 feet to the Sanitary District boundary; thence leaving said line and running along said District boundary South 410.00 feet more or less to the Northerly line of Paradise Drive as realigned by the United States Government in 1944; thence along said Northerly line and said District boundary $S79^{\circ}34'E$, 45 feet more or less; thence along a curve to the right with a radius of 230 feet a distance of 55 feet more or less to the center-line of Paradise Drive as shown on the aforementioned Record Map of Paradise Cove; thence leaving said District boundary and along said center-line $N40^{\circ}39'W$, 35 feet more or less to the Point of Beginning.
