LAS COLINDAS UNITS 6 & 7 ANNEXATION



LEGAL DESCRIPTION

of

LAS COLINDAS UNIT SIX AND SEVEN

ANNEXATION TO: Terra Linda Recreation-Park District
Terra Linda Community Services District

Beginning at a point being the Northeasterly corner of lot 135 as shown on the Map of Las Colindas Unit Four, recorded in Volume 8 of Maps at page 49, Marin County Records; running thence from said point of beginning along said existing District boundary North $71^{\circ} 44'$ West 596.16 feet; thence leaving said existing District boundary North $18^{\circ} 16'$ East 280.0 feet; thence South $71^{\circ} 44'$ East 510.0 feet; thence North $18^{\circ} 16'$ East 13.0 feet; thence South $71^{\circ} 44'$ East 120.0 feet; thence North $18^{\circ} 16'$ East 26.0 feet; thence South $71^{\circ} 44'$ East 154.0 feet; thence South $18^{\circ} 16'$ West 29.0 feet; thence South $71^{\circ} 10' 34''$ East 514.24 feet; thence South $56^{\circ} 31' 51''$ East 95.34 feet; thence South $18^{\circ} 16'$ West 260.0 feet to a point on the existing District boundary said point being the Northwesterly corner of Lot 60 as shown on the map of Las Colindas Unit Three recorded in Volume 8 of Maps at page 44, Marin County Records; running thence along said District boundary North $71^{\circ} 44'$ West 794.06 feet to the point of beginning.
