RESOLUTION NO. 75-4

RESOLUTION MAKING DETERMINATIONS AND APPROVING THE ANNEXATION OF TERRITORY
DESIGNATED AS TERRA LINDA UNIT NO. 27 ANNEXATION
TO THE LAS GALLINAS VALLEY SANITARY DISTRICT

WHEREAS, a proposal for the annexation of certain territory to the Las Gallinas Valley Sanitary District in the County of Marin has been filed with the Executive Officer of this Commission; and

WHEREAS, said proposal was made in the form of Resolution No. 921, a resolution of application adopted by the Board of Directors of the Las Gallinas Valley Sanitary District and requested the initiation of annexation proceedings pursuant to the District Reorganization Act of 1966, Division 1 (commencing with Section 56000) of Title 6 of the Government Code; and

WHEREAS, said resolution of application was accompanied by written consent signed by all owners of land within the territory proposed to be annexed; and

WHEREAS, pursuant to Government Code Section 56261, when a proposal is accompanied by written consent signed by all owners of land within the territory proposed to be annexed, this Commission may make determinations with respect to said application without notice and hearing,

NOW THEREFORE, the Local Agency Formation Commission of the County of Marin DOES HEREBY RESOLVE, DETERMINE AND ORDER as follows:

1. Subject to the terms and conditions hereinafter specified the proposal made by Resolution No. 921 adopted by the Board of Directors of the Las Gallinas Valley Sanitary District is hereby approved.
2. The boundaries of the territory proposed to be annexed shall be those set forth in the proposal filed with this Commission and attached hereto and incorporated herein as Exhibit A; and said territory shall be designated as "Terra Linda Unit No. 27" Annexation and is found to be uninhabited.
3. Any resolution ordering the annexation approved by this resolution shall provide that said annexation is ordered subject to the terms and conditions specified in the resolution of application.
4. The Las Gallinas Valley Sanitary District is designated as the conducting district for further proceedings on said annexation; and the Board of Directors of said district is hereby directed to initiate proceedings in

compliance with this resolution, and is authorized to proceed without notice and hearing pursuant to Government Code Section 56261.


5. The Executive Officer of this Commission is hereby authorized and directed to mail certified copies of this resolution in the manner and as prescribed in Section 56272 of the Government Code.
