RESOLUTION NO. 73-7

RESOLUTION APPROVING THE ANNEXATION OF TERRITORY TO
SANITARY DISTRICT NO. 6

EUCALYPTUS AVENUE ANNEXATION 1973-1

WHEREAS, a resolution of application No. 1360 has been filed by Sanitary District No. 6, together with evidence of written consent of all property owners of property within the proposed annexation; and

WHEREAS, the Commission has found the territory to be annexed to be uninhabited; and

WHEREAS, the Sanitary District No. 6 has not requested the Commission to hold a noticed public hearing in accordance with Government Code Section 56261.

NOW, THEREFORE, BE IT RESOLVED by the Marin County Local Agency Formation Commission, in accordance with the District Reorganization Act of 1965, that it does hereby approve the annexation of territory known as Eucalyptus Avenue Annexation 1973-1 to the Sanitary District No. 6 with the following determination:

1. Sanitary District No. 6 shall be the conducting District for further proceedings to annex this territory and the Board of Directors of that District is directed to initiate annexation proceedings in compliance with this resolution and the resolution of application. Such proceedings may be without notice, without hearing, and without election.
2. The territory proposed for annexation shall be designated as Eucalyptus Avenue Annexation 1973-1.

EXHIBIT "A"

Beginning at a point on the existing boundary of Sanitary District No. 6 of Marin County, said point being on the westerly line of Eucalyptus Avenue distant thereon South 10° 22' West 314.97 feet from its intersection with the southerly line of Center Road, as said Avenue and Road are shown upon that certain map entitled "Amended Map No. 1 of Subdivision 'E' of the Novato Ranch, Marin County, California.", filed July 6, 1910 in Book 3 of Maps at Page 54, Marin County Records; running thence along said Sanitary District boundary and along said westerly line of Eucalyptus Avenue South 10° 22' West 19.63 feet; thence leaving said Sanitary District boundary and continuing along said westerly line of Eucalyptus Avenue South 10° 22' West 645.65 feet to the intersection of the southerly line of Lot 111 (3 O.R. 54), thence leaving said westerly line of Eucalyptus Avenue and running along said southerly line of Lot 111 North 75° 45' West 712.29 feet to a point on said Sanitary District boundary and to the southwesterly corner of said Lot 111; running thence along said Sanitary District boundary and along the westerly line of said Lot 111 North 14° 15' East 660.0 feet; thence leaving said westerly line of Lot 111 and continuing along said Sanitary District boundary South 75° 45' East 553.40 feet; thence leaving said Sanitary District boundary South 75° 45' East 113.97 feet to the point of beginning.
