RESOLUTION APPROVING THE ANNEXATION OF TERRITORY TO  
SANITARY DISTRICT NO. 6

MILL ROAD ANNEXATION 1972-9

WHEREAS, a resolution of application No. 1321 has been filed by Sanitary District No. 6, together with evidence of written consent to all owners of property within the proposed annexation; and

WHEREAS, the Commission has found the territory to be annexed to be uninhabited; and

WHEREAS, the Sanitary District No. 6 has not requested the Commission to hold a noticed public hearing in accordance with Government Code Section 56261.

NOW, THEREFORE, BE IT RESOLVED by the Marin County Local Agency Formation Commission, in accordance with the District Reorganization Act of 1965, that it does hereby approve the annexation of territory known as Mill Road Annexation 1972-9 to Sanitary District No. 6 with the following determinations:

1. Sanitary District No. 6 shall be the conducting District for further proceedings to annex this territory and the Board of Directors of that District is directed to initiate annexation proceedings in compliance with this resolution and the resolution of application. Such proceedings may be without notice, without hearing, and without election.

2. The territory proposed for annexation shall be designated as Mill Road Annexation 1972-9.

**EXHIBIT "A"**

**Parcel 1**

**BEGINNING** at a point on the existing boundary of Sanitary District No. 6 of Marin County, said point being on the northeasterly line of Mill Road at its intersection with the southeasterly line of Lot 205, as said Road and Lot are shown upon that certain map entitled, "Amended Map No. 1 of Subdivision C of the Novato Ranch, Marin County, Calif.", filed July 6, 1910 in Book 3 of Maps at Page 53, Marin County Records; thence leaving said Sanitary District boundary and running along said northeasterly line of Mill Road North 60°45' West 242.67 feet; thence leaving said northeasterly line of Mill Road North 29°15' East 84.39 feet; thence North 19°38' East 65.58 feet; thence North 33°31' West 17.41 feet; thence North 29°15' East 111.53 feet; thence North 60°45' West 60.89 feet; thence North 29°15' East 376.45 feet to a point on the northeasterly line of said Lot 205; thence running along said northeasterly line South 60°45' East 10 feet; thence leaving said northeasterly line North 29°15' East 173 feet; thence South 60°45' East 320 feet to a point on said Sanitary District boundary; running thence along said Sanitary District boundary South 29°15' West 818 feet to the point of beginning.

**Parcel 2**

**BEGINNING** at a point on the existing boundary of Sanitary District No. 6 of Marin County, said point being on the southeasterly line of Trumbull Avenue at its intersection with the northeasterly line of Mill Road as said Avenue and Road are shown upon that certain map entitled, "Amended Map No. 1 of Subdivision C of the Novato Ranch, Marin County, Calif.", filed July 6, 1910 in Book 3 of Maps at Page 53, Marin County Records; running thence from said point of beginning along said Sanitary District boundary and along said southeasterly line of Trumbull Avenue North 29°15' East 214 feet; thence leaving said Sanitary District boundary and said southeasterly line of Trumbull Avenue South 60°45' East 315 feet; thence South 29°15' West 76 feet; thence North 60°45' West 210 feet; thence South 29°15' West 138 feet to a point on said northeasterly line of Mill Road; thence running along said northeasterly line North 60°45' West 105 feet to the point of beginning.
