RESOLUTION APPROVING THE ANNEXATION OF TERRITORY TO  
SANITARY DISTRICT NO. 6

DAVIDSON STREET ANNEXATION 1970-12

WHEREAS, a resolution of application No. 1190 has been filed by  
Sanitary District No. 6, together with evidence of written  
consent of all owners of property within the proposed annexation; and

WHEREAS, the Commission has found the territory to be annexed to be  
uninhabited; and

WHEREAS, the Sanitary District No. 6  
has not requested the Commission to hold a noticed public hearing in accordance  
with Government Code Section 56261.

NOW, THEREFORE, BE IT RESOLVED by the Marin County Local Agency Forma-  
tion Commission, in accordance with the District Reorganization Act of 1965, that  
it does hereby approve the annexation of territory known as Davidson Street  
Annexation 1970-12 to Sanitary District No. 6  
with the following determinations:

1. Sanitary District No. 6 shall  
be the conducting District for further proceedings to annex this territory and  
the Board of Directors of that District is directed to initiate annexation pro-  
ceedings in compliance with this resolution and the resolution of application.  
Such proceedings may be without notice, without hearing, and without election.


2. The territory proposed for annexation shall be designated as  
Davidson Street Annexation 1970-12.

DAVIDSON STREET ANNEX 1970-12

EXHIBIT "A"

BEGINNING at a point on the existing boundary of Sanitary District No. 6 of Marin County, said point being distant North  $64^{\circ} 40'$  West 487.5 feet and South  $38^{\circ} 54'$  West 397 feet from the most southerly corner of Lot 6 as said Lot is shown upon that certain map entitled "Map of East Part Rancho De Novato, Marin County, California", filed March 22, 1889 in Rack 2 Pull 3, Marin County Records, said point being the most southerly corner of that certain parcel conveyed to Sanitary District No. 6 of Marin County by deed May 11, 1948 and filed in Volume 581 at Page 420, Marin County Records; running thence from said point of beginning and from said Sanitary District boundary North  $88^{\circ} 47'$  West 302.133 feet to a point on the proposed future southerly extension of the centerline of Davidson Street; thence running along said future centerline North  $51^{\circ} 06'$  West 312.91 feet to a point on said Sanitary District boundary; thence leaving said future centerline and running along said Sanitary District boundary North  $68^{\circ} 09' 30''$  East 33.57 feet; thence South  $28^{\circ} 36'$  East 49.34 feet; thence North  $61^{\circ} 24'$  East 188.653 feet; thence South  $51^{\circ} 06'$  East 417.825 feet to the point of beginning.
