RESOLUTION APPROVING THE ANNEXATION OF TERRITORY TO  
SANITARY DISTRICT NO. 6

TRUMBULL AVENUE ANNEX 1970-6

WHEREAS, Sanitary District No. 6 of Marin County Resolution No. 1182, a resolution of application to annex certain territory, has been filed with the Executive Officer of this Commission; and

WHEREAS, at the time and in the form and manner provided by law, the Executive Officer has given notice of a public hearing by this Commission upon said resolution; and

WHEREAS, the public hearing by this Commission was held upon the date and at the time specified in said notice of public hearing.

NOW, THEREFORE, the Local Agency Formation Commission of the County of Marin does hereby resolve, determine and order as follows:

1. Sanitary District No. 6 of Marin County Resolution No. 1182 is approved subject to the condition that the same territory is annexed to the City of Novato.

2. The territory proposed for annexation shall be designated as the Trumbull Avenue Annex 1970-6 and is uninhabited.


3. Sanitary District No. 6 shall be the conducting district for further proceedings to annex this territory and the Board of Directors of that district is directed to conduct annexation proceedings in compliance with this resolution and the resolution of application. Such proceedings may be without notice, hearing and election.

Sanitary Annexation Description  
Remaining Portion of Lot 269 (3Maps55)  
**NOVATO SANITARY DISTRICT**

BEGINNING at a point on the easterly boundary of lot 269 (shown as N29.25°E 44.32ch) as shown on that certain map entitled "Map of Subdivision F of the Novato Ranch", recorded July 6, 1910 in Book 3 of Maps at page 55 of Marin County records, said point being South29°15'00"West 220.00 feet along said easterly boundary from the south west corner of lot 246 as shown on that certain map entitled "Amended Map No. 1 of Subdivision C of the Novato Ranch" recorded July 6, 1910 in Book 3 of Maps at page 53 in Marin County Records, and also lying on the Novato Sanitary District Boundary as annexed by the Board of Directors of Novato Sanitary District by said Board's Resolution No. 1038; running thence along the exterior boundary of said Lot 269 (3Maps55) the following courses and distances: South29°15'00"West 725.12 feet; thence South81°32'24"West 263.67 feet; thence South54°24'00"West 290.10 feet, and thence North81°58'00"West 1005.84 feet; running thence along a common line between lots 268 and 269 (3Maps55) North8°44'24"East (recorded as N8.49°E, 3Maps55) 1500 feet more or less to a point on said Novato Sanitary District Boundary (Resolution No. 1038); thence leaving said common line between lots 268 and 269 (3Maps55) and running thence along said Novato Sanitary District Boundary (Resolution No. 1038) South65°00'00"East 1815 feet more or less to the point of BEGINNING.

Containing an area of 43 acres more or less.
