RESOLUTION NO. 73-12

RESOLUTION APPROVING THE ANNEXATION OF TERRITORY TO
SANITARY DISTRICT NO. 6

HILL ROAD ANNEXATION 1973-5

WHEREAS, a resolution of application No. 1376 has been filed by Sanitary District No. 6, together with evidence of written consent to all owners of property within the proposed annexation; and

WHEREAS, the Commission has found the territory to be annexed to be uninhabited; and

WHEREAS, the Sanitary District No. 6 has not requested the Commission to hold a noticed public hearing in accordance with Government Code Section 56261.

NOW, THEREFORE, BE IT RESOLVED by the Marin County Local Agency Formation Commission, in accordance with the District Reorganization Act of 1965, that it does hereby approve the annexation of territory known as Hill Road Annexation 1973-5 to the Sanitary District No. 6 with the following determination:

1. Sanitary District No. 6 shall be the conducting District for further proceedings to annex this territory and the Board of Directors of that District is directed to initiate annexation proceedings in compliance with this resolution and the resolution of application. Such proceedings may be without notice, without hearing, and without election.


2. The territory proposed for annexation shall be designated as Hill Road Annexation 1973-5.

HILL ROAD ANNEXATION 1973-5

EXHIBIT "A"

BEGINNING at a point on the existing boundary of Sanitary District No. 6 of Marin County, California, said point being on the northeasterly line of Hill Road at its intersection with the southeasterly line of Lot 166 as said Road and Lot are shown upon that certain map entitled "Map of Subdivisions 'A' and 'B' of the Novato Ranch, Marin County, Calif.", filed November 18, 1909 in Book 3 of Maps at Page 36, Marin County Records; running thence from said point of beginning along said Sanitary District boundary and along said northeasterly line of Hill Road North $60^{\circ} 45'$ West 335 feet; thence leaving said Sanitary District boundary and said northeasterly line of Hill Road North $29^{\circ} 15'$ East 155 feet; thence North $60^{\circ} 45'$ West 60 feet; thence North $29^{\circ} 15'$ East 234 feet; thence South $60^{\circ} 45'$ East 65.0 feet to a point on the northwesterly line of said Lot 166; thence along said northwesterly line North $29^{\circ} 15'$ East 256.0 feet to a point on said Sanitary District boundary; thence running along said Sanitary District boundary and along the northeasterly line of said Lot 166 South $60^{\circ} 45'$ East 330 feet; thence continuing along said Sanitary District boundary and running along said southeasterly line of Lot 166 South $29^{\circ} 15'$ West 645 feet to the point of beginning.
