RESOLUTION NO. 68-17

RESOLUTION APPROVING THE DETACHMENT OF TERRITORY FROM  
ALMONTE SANITARY DISTRICT DESIGNATED AS THE  
MILL VALLEY DETACHMENT

WHEREAS, a resolution of application No. 4208 N.S. of the City of Mill Valley has been filed with the Executive Officer of this Commission; and

WHEREAS, at the time and in the form and manner provided by law, said Executive Officer has given notice of a public hearing by this Commission upon said resolution; and

WHEREAS, the public hearing by this Commission was held upon the date and at the time and place specified in said notice of public hearing.

NOW, THEREFORE, the Local Agency Formation Commission of the County of Marin does hereby resolve, determine, and order as follows:

1. The detachment is approved and the boundaries of the proposed detachment are as shown on Exhibit A attached hereto and by this reference incorporated herein.
2. The territory proposed for detachment is found to be uninhabited.
3. The territory proposed for detachment shall be designated as the Mill Valley Detachment.
4. The Almonte Sanitary District shall be the conducting district for further proceedings to detach this territory and the Board of Directors of that district is directed to initiate detachment proceedings in compliance with this resolution.
5. The Executive Officer is hereby authorized to mail certified copies of this resolution in the manner provided in Section 56272 of the Government Code.





RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILL VALLEY  
MAKING APPLICATION FOR WITHDRAWAL OF TERRITORY FROM ALMONTE  
SANITARY DISTRICT

WHEREAS, the City Council of the CITY OF MILL VALLEY desires to initiate proceedings for withdrawal from the ALMONTE SANITARY DISTRICT of the territory hereinafter described;

NOW, THEREFORE, the City Council of the CITY OF MILL VALLEY does hereby RESOLVE, ORDER AND DECLARE as follows:

SECTION 1. Application and a proposal is hereby made to the Local Agency Formation Commission of the County of Marin for a change of organization as follows:

(a) This proposal is made pursuant to the District Reorganization Act of 1965, commencing with Government Code Section 56000.

(b) The nature of the proposed change of organization and the names of all districts and cities for which any such change of organization is proposed are as follows: The withdrawal of the hereinafter described territory from the ALMONTE SANITARY DISTRICT, said territory having heretofore been annexed to the CITY OF MILL VALLEY.

(c) The names of all other affected counties, cities and districts are: County of Marin.

(d) The territory proposed to be withdrawn from the ALMONTE SANITARY DISTRICT is uninhabited and a description of the exterior boundaries of such territory is set forth in Exhibit "A", attached hereto and incorporated herein by reference.

(e) It is not desired that said proposed change of organization be made subject to any terms and conditions.

(f) The reasons for this proposal are as follows: The territory described in Exhibit "A" hereto has heretofore been annexed to the CITY OF MILL VALLEY. The CITY OF MILL VALLEY maintains a sewage collection and disposal system for which it levies a tax upon all property within the City. The ALMONTE SANITARY DISTRICT similarly levies a tax on property within its territory for the service of sewage collection and disposal rendered by it.

The sewage collection system of the ALMONTE SANITARY DISTRICT discharges into the CITY OF MILL VALLEY treatment plant. In order to avoid duplicate taxes, it is necessary that the territory involved be withdrawn from the ALMONTE SANITARY DISTRICT.

(E) A request is hereby made that the Local Agency Formation Commission undertake proceedings for the change of organization proposed herein.

SECTION 2. The City Clerk of the CITY OF MILL VALLEY is hereby authorized and directed to file a certified copy of this resolution with the Executive Officer of the Local Agency Formation Commission of the County of Marin.
