

LOCAL AGENCY FORMATION COMMISSION OF THE COUNTY OF MARIN

RESOLUTION NO. 71-21

AMENDED RESOLUTION APPROVING THE REORGANIZATION INVOLVING THE
DISSOLUTION OF THE TERRA LINDA COMMUNITY SERVICES DISTRICT
AND THE TERRA LINDA RECREATION-PARK DISTRICT AND THE
FORMATION OF THE NEW TERRA LINDA COMMUNITY SERVICES DISTRICT

WHEREAS, Terra Linda Recreation-Park District Resolution No. 47, proposing a reorganization consisting of dissolution of the Terra Linda Recreation-Park District and a transfer of that district's responsibilities to the Terra Linda Community Services District together with annexation and tax override to the latter district as necessary, was filed with the Executive Officer of the Local Agency Formation Commission; and

WHEREAS, on October 14, 1970, following a public hearing, this Commission by Resolution No. 70-42 referred the resolution of application to a reorganization committee consisting of representatives of the Terra Linda Recreation-Park District and the Terra Linda Community Services District, with instructions for the reorganization committee to report within ninety days; and

WHEREAS, by Resolution No. 71-4, this Commission extended the time period for reporting of the reorganization committee to February 10, 1971; and

WHEREAS, on February 10, 1971, this Commission received verbally the report of the reorganization committee; and

WHEREAS, on March 10, 1971, this Commission opened its hearing on said report and the hearing was continued to this date; and

WHEREAS, on May 12, 1971, this Commission approved Resolution No. 71-17; and

WHEREAS, the Las Gallinas Valley Sanitary District requested deletion of garbage and refuse collection services from Resolution No. 71-17.

NOW, THEREFORE, the Local Agency Formation Commission of the County of Marin does hereby resolve, determine and order as follows:

1. A reorganization involving the dissolution of the Terra Linda Recreation-Park District and the Terra Linda Community Services District and the formation of the new Terra Linda Community Services District is approved subject to the following conditions:

A. A. A tax rate of \$1.50 per \$100 assessed valuation for the new Community Services District is authorized by the voters

B. The Board of Directors of the new district shall be five in number and they shall be elected concurrently with the election on the reorganization itself.

C. The new Community Services District shall have the following powers:

- i. Fire protection
- ii. Police protection
- iii. Public recreation including parks
- iv. Street lighting
- v. Conversion of utilities to underground locations

D. The new Community Services District shall be the successor to the Terra Linda Community Services District and the Terra Linda Recreation-Park District.

E. All property and assets of the two existing districts shall be transferred to the new Community Services District on the effective date of the reorganization.

2. The boundaries of the proposed Terra Linda Community Services District shall be identical with those of the present Terra Linda Community Services District.

3. The territory proposed for reorganization is found to be inhabited.

4. The Marin County Board of Supervisors is hereby directed to initiate proceedings in compliance with this resolution.


