RESOLUTION NO. 76-17

RESOLUTION MAKING DETERMINATIONS AND DENYING THE DETACHMENT DESIGNATED
AS "HAMILTON AIR FORCE BASE-RAFAEL VILLAGE DETACHMENT"
FROM THE NOVATO FIRE PROTECTION DISTRICT

WHEREAS, a proposal for the detachment of certain territory from the Novato Fire Protection District has been filed with the Executive Officer of this Commission; and

WHEREAS, said proposal was made in the form of Resolution No. 76-1, a resolution of application, adopted by the Board of Directors of the Novato Fire Protection District, and requested initiation of detachment proceedings in accordance with the provisions of the District Reorganization Act of 1965, Division 1 (commencing with Section 56000) of Title 6 of the Government Code; and

WHEREAS, at the time and in the form and manner prescribed by law, the Executive Officer has given notice of public hearing by this Commission on said proposal; and

WHEREAS, the public hearing on said proposal was held by this Commission upon the date and at the time specified in said notice of public hearing; and

WHEREAS, at said hearing, this Commission heard and received all oral and written protests, objections and evidence for and against the proposal made, presented or filed,

NOW, THEREFORE, the Local Agency Formation Commission of the County of Marin DOES HEREBY RESOLVE, DETERMINE AND ORDER as follows:

1. The proposal, made by Resolution No. 76-1 of the Board of Directors of the Novato Fire Protection District, to detach that area designated as "Hamilton Field and Rafael Village Detachment" is hereby denied.
2. The denial is made without prejudice for filing of a new proposal for detachment of all or any portion of the territory included in the subject proposal at any time there is evidence that the Novato Fire Protection District is being required to provide services without

reasonable compensation therefore, either through tax revenues or negotiated contract, and, to this extent the provisions of Government Code Section 56273 are hereby waived on the basis that, prior to one year from this date, it may be necessary to reconsider all or a portion of the subject detachment in order to protect the interest of the residents and taxpayers of the Novato Fire Protection District.


3. The Executive Officer is hereby authorized to mail certified copies of this resolution in the manner and as prescribed in Section 56272 of the Government Code.
