RESOLUTION NO. 66-45

RESOLUTION APPROVING THE ANNEXATION OF TERRITORY TO
SANITARY DISTRICT NO. 6:
HILL ROAD ANNEXATION NO. 2 (1966-12)

WHEREAS, a resolution of application has been filed, together with evidence of written consent of all owners of property within the proposed annexation; and

WHEREAS, the Commission has found the territory to be annexed to be uninhabited; and

WHEREAS, the Sanitary District No. 6 of Marin County has not requested the Commission to hold a noticed public hearing in accordance with Government Code Section 56261.

NOW, THEREFORE, BE IT RESOLVED by the Marin County Local Agency Formation Commission, in accordance with the District Reorganization Act of 1965, that it does hereby approve the annexation of territory known as Hill Road Annexation No. 2 (1966-12) to Sanitary District No. 6 of Marin County with the following determinations:

1. Sanitary District No. 6 of Marin County

shall be the conducting District for further proceedings to annex this territory and the Board of Directors of that District is directed to initiate annexation proceedings in compliance with this resolution. Such proceedings may be without notice of hearing and without election.

2. The territory proposed for annexation shall be designated as Hill Road Annexation No. 2 (1966-12).

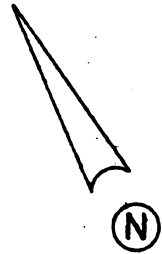
BEGINNING at a point on the existing boundary of Sanitary District No. 6 of Marin County, said point being at the intersection of the Southerly line of Hill Road with the Westerly line of Lot 188 as shown upon that certain map entitled "Map of Subdivisions A and B of the Novato Ranch, Marin County, Calif." filed November 18, 1909 in Book 3 of Maps at Page 36, Marin County Records. Running thence along said Sanitary District boundary and along said Southerly line of Hill Road South $60^{\circ} 45'$ East 314.54 feet to a point on the Westerly line of Arroyo Aviche Road; thence leaving said Southerly line of Hill Road and running along said Westerly line of Arroyo Aviche Road South $15^{\circ} 15'$ West 452.85 feet; thence leaving said Sanitary District boundary and said Westerly line of Arroyo Aviche Road North $67^{\circ} 07' 28''$ West 110.00 feet; thence South $14^{\circ} 35' 35''$ West 200 feet to the Southerly line of said Lot 188; thence running along said Southerly line North $60^{\circ} 45'$ West 369.54 feet to the most Westerly corner of said Lot 188; thence running along said Westerly line of Lot 188 North $29^{\circ} 15'$ East 645 feet to the point of beginning.
