RESOLUTION NO. 80-2

RESOLUTION MAKING DETERMINATIONS  
APPROVING ANNEXATION OF TERRITORY  
TO THE CITY OF SAUSALITO

WOLFBACK RIDGE ANNEXATION NO. 2

WHEREAS, a proposal for annexation of certain unincorporated territory to the City of Sausalito has been filed with the Executive Officer of this Commission; and

WHEREAS, said proposal was made in the form of a petition submitted by the affected landowners and registered voters requesting the initiation of annexation proceedings in accordance with the provisions of the Municipal Organization Act of 1977, commencing with Section 35000 of the California Government Code; and,

WHEREAS, said resolution proposed annexation of unincorporated territory to the City of Sausalito in compliance with State law; and,

WHEREAS, the Executive Officer of this Commission has issued a certificate of filing, accepting said legal documents; and,

WHEREAS, legal notice of hearing was published and notice of hearing was forwarded in accordance with State requirements; and,

WHEREAS, the Marin Local Agency Formation Commission conducted a public hearing, at which time all persons present were given an opportunity to speak and be heard regarding this annexation proposal; and,

WHEREAS, the Commission considered the Executive Officer's report and recommendations.

NOW, THEREFORE, the Local Agency Formation Commission of the County of Marin, DOES HEREBY RESOLVE, DETERMINE AND ORDER as follows:

Section 1. The boundaries of the territory proposed to be annexed shall be those set forth in Exhibit A, attached hereto and incorporated herein; and, said territory shall be designated as "Wolfback Ridge Annexation No. 2".

Section 2. Said proposal is hereby approved.

Section 3. Said territory is inhabited.

Section 4. In accordance with applicable provisions contained in the adopted Marin LAFCO Environmental Guidelines and Procedures, the City of Sausalito is the appropriate lead agency, has conducted an initial study incorporating concern of said Commission, a responsible

agency, and has issued a Negative Declaration. The Commission has considered environmental documents germane to said proposal.

Section 5. The Sausalito City Council is hereby determined to be the appropriate conducting authority to complete annexation proceedings and is directed to proceed.


Section 6. The Executive Officer is hereby authorized to mail certified copies of this Resolution in the manner and as prescribed by law.

WOLFBACK RIDGE ANNEXATION

to the

CITY OF SAUSALITO

Beginning at a point S 26°51' W 64.3 ft. from the Southerly corner of Parcel 2 as shown in Book 7 of Parcel Maps at Page 84 recorded October 11, 1972, in Marin County Records, running thence N 26°51' E 214.61 ft.; thence N 21°36'50" E 349.16 ft. plus or minus to an angle point in the Corporate Limit boundary of the City of Sausalito; thence running along said City line the following: N 57°30' W 180 ft.; thence N 48°00' W 300 ft.; thence N 63°30' W 50 ft.; thence N 75°15' W 170 ft.; thence N 21°00' W 73 ft.; thence N 54°30' W 70 ft.; thence N 52°30' W 70 ft.; thence N 31°15' W 118 ft.; thence N 24° W 250 ft.; thence N 3° W 222.10 ft.; thence S 51°16' W 146.62 ft.; thence N 3° W 40 ft.; thence N 51°15' E 11.42 ft.; thence N 38°44' W 104 ft.; thence S 51°16' W 60 ft.; thence N 38°44' W 104 ft.; thence S 51°16' W 147.08 ft.; thence S 34°36' E 26.61 ft.; thence S 38°44' E 181.46 ft.; thence S 51°16' W 15 ft.; thence leaving said boundary line on a curve to the left whose center bears S 51°16' W and whose radius is 120 ft. distance 10.50 ft.; thence along the most Southwesterly line of Lot 11A as shown in Book 10 of Surveys, page 77, filed November 3rd, 1971 at Marin County Records S 38°44' E 60 ft. to a point on the boundary of the land known as the Golden Gate National Recreation Area as shown in the Record of Survey filed in Book 3, page 62 on the 21st of April, 1964 in the Marin County Records; thence along said boundary line the following: S 19°30'04" E 415.60 ft.; thence S 17°59'04" E 270.21 ft.; thence S 49°21'13" E 1038.86 ft.; thence leaving said boundary line N 66°06' E 22.69 ft.; thence S 89°55' E 10.03 ft. more or less to the point of beginning.
