RESOLUTION NO. 81-32

RESOLUTION MAKING DETERMINATIONS AND APPROVING DISSOLUTION OF
COUNTY SERVICE AREA NO. 4

WHEREAS, a proposal for dissolution of County Service Area No. 4 has been filed with the Executive Officer of this Commission; and

WHEREAS, said proposal was made in the form of Resolution No. 81-226, a resolution of application adopted by the Board of Supervisors of the County of Marin, requesting initiation of preliminary proceedings pursuant to the District Reorganization Act of 1965, Title 6, Division 1 (commencing with Section 56000 of the Government Code); and,

WHEREAS, at the time and in the form and manner prescribed by law, the Executive Officer has given notice of public hearing by this Commission upon said proposal; and,

WHEREAS, the public hearing on said proposal was held by this Commission upon the date and at the time and place specified in said notice of public hearing, and all interested persons present were afforded an opportunity to speak and be heard on the matter.

NOW, THEREFORE, the Local Agency Formation Commission of the County of Marin DOES HEREBY RESOLVE, DETERMINE AND ORDER as follows:

Section 1. The dissolution proposal is approved.

Section 2. The boundaries of the territory proposed for dissolution shall be those set forth in Exhibit A, attached hereto and incorporated herein.

Section 3. Said approval is subject to the following terms and conditions:

- A. That the effective date of said dissolution shall be set to coincide with the effective date of the annexation of said property to the Marin County Highway Lighting District.
- B. The proposal shall be subject to applicable terms and conditions specified in Sections 56500 and 56513 inclusive as deemed appropriate by the County Board of Supervisors.

Section 4. The Marin Board of Supervisors, pursuant to Section 56274 of the Government Code, is hereby directed to initiate such proceedings in compliance with this resolution and provisions of law.

Section 5. The project is categorically exempt pursuant to provisions of the California Environmental Quality Act and the Commission's Environmental Guidelines.
